# Planning Division Highlights

The State of California and local jurisdictions establish criteria for public review of many types of projects. The following is an abbreviated list of the programs, projects, and proposals under consideration by the City of Solana Beach. For more information, contact the City staff member assigned to the project at the phone number listed.

## WHAT IS THE LCP?

The Local Coastal Program (LCP) is a coastal management plan mandated by the California Coastal Act of 1976. An LCP contains land use, development, public access, and resource protection policies and regulations that implement the Coastal Act at the local level. It is comprised of a Land Use Plan (LUP) and a Local Implementation Plan (LIP or IP). The City has its LUP and is now working on its IP. The City's approved LUP can be viewed online on the City's website and in person at the Community Development Department at the City of Solana Beach City Hall. Every local government in the coastal zone (61 cities and 15 counties) is required to prepare an LCP and submit it to the California Coastal Commission (CCC) for review and approval. The City is one of six coastal cities without a certified LCP, and the entire City of Solana Beach is located within the coastal zone.

**WHY CERTIFY?** Currently, residents and business owners with projects requiring a discretionary permit must apply to, have their permits approved by the City, and then apply as well to the Coastal Commission for approval. In most instances, certification of the City's LCP will allow the City to issue these permits.

After certification, the City would process the majority of permit applications, instead of the CCC. In addition to the convenience of filing at Solana Beach City Hall, permit applications would be processed by your open and responsive Community Development Department staff, which means your application can be processed much faster. All this will translate into less time and lower application costs.

**HOW WILL LCP CERTIFICATION AFFECT WHAT I CAN DO ON MY PROPERTY?** Most of the LCP content is taken from the City's Zoning Code. Therefore, land use, setbacks, height limits, floor area limits, off-street parking, and other development regulations will remain largely unchanged. For properties located along the bluffs, the development standards would be tied to the policies contained within the Certified LUP. Blufftop properties are within the "appealable" Coastal Development Permit (CDP) area subject to additional CCC review. The City is exploring the geographic segmentation of bluff-top properties from the rest of the City to move forward with the LIP for the remaining 95% of the area within the City.

If you have a project that requires a permit, the LCP will provide a set of procedures for obtaining a CDP from the City. Like the CCC, the City would ensure that the CDP is issued in conformance with the policies of the Coastal Act. Therefore, issues of land use, public access, and protection of resources will have to be addressed as appropriate for Solana Beach. (Joseph Lim 720-2434)

## DRAFT PUBLIC RECREATION IMPACT FEE STUDY

The City Council approved the updated Draft Public Recreation Impact Fee Study and LUP Amendment with the adoption of Resolution 2016-039 on April 13, 2016. The Draft Fee Study and LUP Amendment was submitted to the California Coastal Commission on April 29, 2016. The Draft Fee Study and LUP Amendment are posted on the City website.

In conjunction with the ongoing Local Coastal Plan (LCP) certification process with the California Coastal Commission (CCC), the City agreed to partner with the CCC to update the 2010 Public Recreation/Land Lease Impact Mitigation Fee Study. The purpose of the land lease/recreation mitigation fee is to compensate the public for the loss of recreational use of the beach due to the installation of shoreline protective devices such as seawalls. In May 2014, Council approved an agreement with the CCC to accept \$120,000 in grant funding to be used primarily to support the preparation of an update to the 2010 fee study. The first public meeting for the fee study update was held at City Hall in September 2014.

The Fee Study update was needed to incorporate and reflect the certified Land Use Plan (LUP) policies and to review comments on the 2010 fee study. Also, CCC staff requested that the City's fee study update ensure adequate representation of surfers as users of the public beach and incorporate recent and relevant coastal bluff erosion studies and sea-level rise projections into the fee study update.

The CCC held a public hearing on the LUP Amendment at its May 2017 meeting in San Diego. The CCC approved the fee study with 16 modifications as recommended by the CCC staff. On November 8, 2017, the City Council directed staff to pursue geographic segmentation of the bluff top properties from the rest of the City in the LIP and authorized the City Manager to request a one-year extension from the CCC on the Fee Study LUP Amendment. On November 13, 2018, the City Council adopted all the CCC "Suggested Modifications" on the City's Fee Study and LUPA. On December 13, 2018, the CCC concurred with the Executive Director's determination that the City's actions are legally adequate pertaining to the adoption of a public recreation fee associated with shoreline development. City staff continues to work on the draft LIP that would geographically segment the bluff top properties from the rest of the City. (Joseph Lim 720-2434)

## BEACH SAND REPLENISHMENT AND RETENTION PROJECTS

**SAN ELIJO LAGOON RESTORATION PROJECT** The San Elijo Lagoon Restoration Project (SELRP) is designed to improve the ecological function and tidal flow of San Elijo Lagoon and will address the impacts of historical development and infrastructure in and around the lagoon. The SELRP has two components: the restoration of San Elijo Lagoon and the reuse of beach quality sand excavated during the restoration. The project will create a more connected gradient of habitat types relative to existing conditions through modifications to channels and habitat areas within the lagoon. Lagoon restoration has generated approximately 750,000 cubic yards of beach sand through excavation. The project involved the creation of an over-dredge pit to provide larger-grained sand suitable for reuse local beaches, which was to be exported from the site. Placement of the sand occurred in the Spring of 2018 at two beach receiver sites (Cardiff and Solana Beach/Fletcher Cove). Beach replenishment operations took place 24 hours a day, seven days a week with crews pumping 146,000 cubic yards of sand from the lagoon and placing it at Fletcher Cove Beach.

**50-YEAR USACE COASTAL STORM DAMAGE REDUCTION PROJECT** The Cities of Solana Beach and Encinitas have also been working for more than 16 years as the local sponsors of a long-term coastal storm damage reduction/shoreline protection project with the state and federal government. The state entity directly involved in financially supporting the project is the California State Parks, Division of Boating and Waterways (DBW). This beach replenishment project has been designed to be resilient to various future sea-level rise scenarios over its 50-year life based on National Research Council (NRC) data recommended for use by the California Coastal Commission (CCC).

The project is also consistent with the 2014 adopted CCC Sea Level Rise Policy Guidance document, which recognizes beach nourishment as a preferred sea level rise adaptation strategy for developed coastlines. The project received a unanimous vote of support from the CCC following a public hearing in November 2013. With project implementation, the beaches would be re-nourished on a regular cycle during a Federal and State investment and participation period of 50 years. (Leslea Meyerhoff 720-2446)

The Solana Beach-Encinitas shore protection project received congressional “authorization” in the 2016 Water Resources Development Act, and the “Record of Decision” was signed in June 2017. This makes the project eligible to receive federal funds for construction. First, however, federal funding for Pre-Construction Engineering and Design (PED) must be secured. The PED provides all the details that the U.S. Army Corps of Engineers (USACE) and its contractors will need to construct the project (or place sand) along the coastline, details quantities of sand to be placed on the beach, and identifies the locations and quantities from each area of the underwater sites that will be used to obtain the sand. The Solana Beach project consists of a 150-foot wide placement of sand on the beach, and the Encinitas project consists of a 50-foot wide beach.

**SCOUP** In 2018, the City completed the process to extend its Sand Compatibility and Opportunistic Use Program (SCOUP) for another five years which extends new permit approvals received from the California State Lands Commission, CCC, USACE, and Regional Water Quality Control Board through 2024. The City’s SCOUP program is a critical element of the City’s long-term shoreline management program and is a key sea level rise adaptation strategy. The SCOUP program allows placement of beach compatible sands on the City’s beaches, up to 150,000 cubic yards per year. City Staff are currently tracking several local projects that may generate beach quality export material.

The lead-time to develop a SCOUP project is approximately six months, and early coordination with City Staff is important to facilitate final reviews and approvals by the agencies of the sampling and analysis plan (SAP) as well as placement details, monitoring requirements and other logistics. **ANNUAL SHORELINE MONITORING PROGRAM** The City of Solana Beach, in conjunction with SANDAG and other participating cities, continue to monitor the performance of the beach sand project and the overall health of the public beach through local and regional beach profile data collection and monitoring efforts conducted in the spring and fall each year. The City has an agreement with Coastal Frontiers for ongoing shoreline monitoring services.

## CURRENT PLANNING ACTIVITIES

In addition to the aforementioned programs and projects, the Community Development Department provides a variety of services to the public including, but not limited to, zoning and land use information, development permit processing, view assessment processing, building plan check and permit review/issuance, inspections and code compliance. The Department is also responsible for preparing updates to the City's General Plan, including Housing Element updates, maintenance, and updates to the City's Municipal Code, as well as other Specific Plan amendments for City Council consideration. The majority of projects that are processed are for single-family residential modifications, additions or renovations. However, the following is a brief list/summary of the projects that have been or will be considered by City Council:

**330 South Cedros** – In December 2016, the City Council approved a mixed-use development consisting of four commercial retail spaces, a restaurant and a parking lot with 18 uncovered and 60 covered parking spaces on the ground floor and five offices spaces and eight (8) multi-family rental apartments on the second floor. Project construction started in the summer of 2018 and is near completion.

**Solana 101 project** – On July 10, 2018, the City Council approved a mixed-use development consisting of 45,587 square feet of commercial office space, 10, 562 square feet of restaurant space, 2,920 square feet of outdoor dining space, 4,142 square feet of retail space, 25 multi-family residential rental units and two levels of subterranean parking with 366 spaces. In February 2019, the California Coastal Commission approved a Coastal Development Permit for the project consistent with City Council approval. The applicant is preparing construction drawings for City review and anticipates breaking ground for the project in 2019.

**Solana Highlands project** – On December 17, 2018, the City Council approved a residential development consisting of 260 residences (including 32 affordable senior units). The project consists of studios, one- and two-bedroom units, 10,287 square feet of clubhouse/leasing office space, 261,266 square feet of landscaped area, 65,434 square feet of open space, 525 on-site parking spaces including 233 garages, 22 covered spaces, and 270 open/guest spaces. A Coastal Development Permit was approved by the California Coastal Commission for the project in Spring 2019.

**Housing and Safety Element update** – All California cities are required to adopt a Housing Element as part of their General Plan. Housing Elements are subject to detailed statutory requirements as well as mandatory review by the California Housing and Community Development Department. These Housing Elements are required to be updated at least every eight (8) years and are expected to include policies that address the State's housing crisis and encourage housing development. The City's current housing element was certified by HCD in 2013. The next cycle for preparing the City's Housing Element has begun, and the State and San Diego Association of Governments are working on each City's Regional Housing Needs Assessment (RHNA). On August 28, 2019, the City Council selected Kimley-Horn Associates to assist with the preparation of the City's Housing and Safety Element Update.

**Distillery Lot Request for Proposals** – On February 27, 2019, the City Council authorized the City Manager to issue a Request for Proposal (RFP) from qualified, affordable housing developers to develop 20-27 very low- or low-income dwelling units on a 1-acre parcel located at the public parking lot at 140 South Sierra Avenue. The site is zoned General Commercial and is located within the Plaza District of the Highway 101 Corridor Specific Plan and is currently developed with approximately 117 public parking spaces. Program 19 of the City's Housing Element identifies three City-owned sites in the Residential Land Inventory that are viable for affordable housing. This program calls for the City to issue an RFP for affordable housing development for all three sites. The City received one proposal that includes a mixed-use affordable housing project. The City is currently reviewing and evaluating the proposal.

**Harbaugh Seaside Trails project** – In 2017 the City Council approved a request by the San Elijo Lagoon Conservancy to amend the City's General Plan and Rezone the property at 640 North Highway 101 from Commercial to Open Space. The property is adjacent to the existing San Elijo Lagoon Ecological Preserve. In February 2018, the City Council approved a Development Review Permit to perform habitat restoration, minor grading, and construction of approximately 2,080 linear feet of public trail improvements which were subsequently approved by the California Coastal Commission in February 2019. Grading permits were issued by the City and construction began in mid-February.

**Permit Tracking Software** – For the past two years, the City has been working with a vendor to install and implement permit tracking software for a variety of permits and licenses including, but not limited to, business certificates, short-term vacation rental permits, building and fire permits, encroachment permits, and various discretionary permits (i.e. development review, conditional use, variance, subdivisions, and structure development permits). At the end of June 2019, the City went live with the new software now known as Community Development (formerly TRAKiT). Soon the City plans on launching a public interface that will allow applicants and the public to review the status of projects and permits as well as schedule certain inspections online.



## Lifeguards

Each summer has its share of excitement, and the summer of 2019 was no different. The Solana Beach Marine Safety Department hired 12 new seasonal lifeguards for this summer, many of whom worked full time, providing safety and information to thousands of beach patrons. Some of the highlights of this summer besides making rescues and treating an abundance of stingray patients included working with the CSU Long Beach shark lab, winning the Oceanside Firefighters annual Charity Fund Team Surf Contest and facilitating black seabass research at Scripps.

This summer there were several juvenile shark sightings in San Diego County. This created interest from the California State University Long Beach Shark Lab. The Solana Beach Lifeguards partnered with researchers from the shark lab on multiple occasions to help spot, identify and even attempt to tag these juvenile sharks. Experts from the shark lab stated that southern California is a nursery habitat for young sharks and that their primary food source is stingrays.

On Saturday, August 10<sup>th</sup>, the Solana Beach lifeguards, led by Surf Team Captain Brett Jones, won the annual Oceanside Firefighters Charity Fund Surf Contest. The final round was comprised of Solana Beach Rookie Lifeguard Taylor Clark (1st place), SB Senior Lifeguard Brett Jones (3rd place), SB Rookie Lifeguard Dom Pazanowski (6th place). SB Veteran Lifeguard, new father, and previous event winner Skylar Stokes made the semifinal.

Three pillars of lifeguarding are prevention, rescues, and medical aids but lifeguards deal with many other unusual occurrences throughout the year. One such incident happened on the evening of Saturday, August 17<sup>th</sup>, when a Giant Black Seabass washed up onshore. The Giant Black Seabass weighing approximately 75 pounds and measuring over 4 feet long was removed from the water by lifeguard Kinsey Bettencourt. Giant Black Seabass' are critically endangered, and after many failed attempts to contact Scripps, NOAA, and the National Marine Fisheries, lifeguards were resigned to the fact that the impressive fish was going to go to waste. Just before closing time, a personal friend of the lifeguards and former Solana Beach resident put the lifeguards in contact with Ph.D. candidate Kayla Blincow, one of only two researchers who study Giant Black Seabass at Scripps. Blincow excitedly picked up the fish and brought it to her Lab to dissect and further the understanding of this species.

Finally, the Solana Beach Lifeguards would like to remind everyone to swim near a lifeguard, shuffle your feet to avoid stingrays and to stay clear of all bluffs, overhangs, and caves, as they are prone to erosion.

# Junior Lifeguards

This past summer flew by for Solana Beach Junior Lifeguards! We are so thankful for all the families and children that joined us down on the beach this summer. Solana Beach Junior Lifeguards has a long history of serving our community by providing youth, ages 7 – 16, with an ocean safety program that combines athletics, ocean-related curriculum, and fun. The program is located at Seascapes Beach, just south of Fletcher Cove. This summer, we had over a thousand children as participants for Junior Lifeguards. We implemented a brand-new Junior Lifeguard Surf Class, which was a huge success and a lot of fun. The Surf Class was offered in ten, one-week sessions and was a great instructional surfing class that fits alongside the other JG programs. Elite Junior Lifeguards was another new option. This session receives physical and hands-on lifeguard training while also shadowing other members of our Marine Safety team in the towers. The Elites received American Red Cross CPR training and certification, with the hopes that the graduates of the Elite program will come back in future years to work as lifeguards!



Junior Lifeguards is an excellent way for local children to learn to be safe in the ocean environment while still having a blast. We offer Junior Lifeguards as both a two week and four-week session. The two-week program serves as an introductory program, and the four-week program has a more in-depth curriculum. All sessions will include moderate physical activity, ocean rescue, safety topics, beach-related first-aid, team building activities/games, wave riding, and free diving! We want to use this program to grow the participant's safety and comfort at the beach and in the ocean.

We had a great summer on the beach during the course of the program with our Competition Day with other Junior Lifeguard agencies, guest presentations, surf contests, Cookie Days, Two-Mile Tuesdays, and the Lifeguard Station tours. We are bummed to be wrapping up our ten-week season but are very excited for next summer! Please be sure to check out the DVDs from our Junior Lifeguard Session on the homepage of our website. 




# Household Hazardous Waste & E-Waste Program

The door-to-door or home HHW collection service is available to qualifying homebound or senior residents (age 65 and over) at no charge. All other Solana Beach residents are eligible for HHW home pickup for a copayment of \$10. This service does not include pickup of regular trash, business waste, medical or biological waste, explosives, ammunition, or radioactive material. To schedule an appointment for HHW collection, please call 858-481-7233. In addition to the door-to-door collection service, there are two regional permanent collection centers which are open every Saturday (except holiday weekends) from 9 A.M. to 3 P.M. The City of Vista collection center is located at 1145 East Taylor Street, at Laguna Lane. The City of Poway collection center is located in the South Poway Business Park, at 12325 Crosthwaite Circle, off Stowe Drive.

## What Goes in Your Blue Recycling Cart?

Knowing what can be recycled is a major step towards reducing contamination in recycling carts. Below is a list of many acceptable items in EDCO's recycling program. Keeping trash and other non-recyclable items out of recycling carts is another important step. If possible, you should never isolate recycling containers. By setting recycling containers and trash containers side-by-side throughout your home you reduce the risk of recycling contamination. Having recycling containers without a readily available trash container might lead others to throw trash in with the recycling.

### RECYCLE

These items go inside EDCO's blue commingled recycling carts!



#### MIXED PAPER:

Mixed paper, including junk mail, catalogs, telephone books, magazines, newspaper, and paper used for computer printing.



#### STYROFOAM:

Clean foam cups, meat trays, plates, egg cartons, block packaging, rigid polystyrene, and carry-out containers.



#### GLASS CONTAINERS:

Glass containers including food jars and beverage bottles.



#### PAPERBOARD:

Paperboard boxes such as cereal boxes, tissue boxes, refrigerated food boxes, boxes from toiletries, and soda/beer cases.



#### CARTON CONTAINERS:

Aseptic cartons, including milk cartons and juice boxes, half-gallon juice cartons, soup/broth cartons, and wine cartons.



#### METAL:

Dry and empty paint and aerosol cans.



#### SHREDDED PAPER:

Shredded paper (placed in a sealed, labeled paper bag or clear plastic bag for easier handling).



#### CARDBOARD:

Cardboard, including boxes used for moving and shipping or any other box or packaging made of corrugated cardboard.



#### ALUMINUM & STEEL:

Aluminum, steel and tin cans, such as food and beverage cans for soda, soup, beer, beans, fruit, and vegetables. Clean aluminum foil, clean aluminum trays, and pie tins.



#### #1 - #7 PLASTICS:

All plastic containers, lids, and packaging with a recycling symbol of #1-7 (all containers accepted with caps and lids): water and soda bottles, peanut butter and other food jars, mouthwash bottles, vegetable oil containers, automotive oil containers, ovenable food trays, milk jugs, juice bottles, shampoo and conditioner bottles, detergent and bleach containers, condiment bottles, medicine bottles, bottle caps, butter and yogurt tubs, CD cases, baby bottles, 5-gallon water bottles, CDs, medical storage containers, and rigid plastics such as 5-gallon buckets.

*\*All food and beverage containers require light rinsing only if soiled with food and liquids.*

## What Goes in Your Gray Trash Cart?

Use your gray trash cart to dispose of non-recyclable household trash. Residents can request additional trash carts for a nominal fee. Household trash includes, but is not limited to:

# Storm Water Program (Water Quality)

The City of Solana Beach is committed to protecting and enhancing water quality in our local receiving bodies of water. Our beautiful City is bounded by San Elijo Lagoon to the north, San Dieguito Lagoon to the south, and of course, the Pacific Ocean to the west. Unlike the sanitary sewer system, storm drain runoffs are typically not treated and would simply gravity flow to our local waterways and eventually reaching our beautiful beaches and the Pacific Ocean. Therefore, protecting the network of public and private storm drains are crucial to maintaining a clean and healthy water environment.

Legally, **only rain should enter storm drains**. So what can residents and business owners in Solana Beach do to help prevent pollutants from entering the storm drain? Below is a list of tips and recommendations:

Maintain clean surroundings around your home and/or business. If a known pollutant is left unattended or ignored, such as trash, oil drippings and dirt erosion, chances are it will get washed away into a nearby storm drain inlet the next time we see rain.

Keep landscape watering at a minimum, and if possible, avoid excess water from entering the street.



Plant vegetation or temporary erosion control devices such as fiber roll or jute matting on bare soils, especially on slopes to prevent erosion. If possible, complete planting prior to the rainy season.

Properly dispose of used oil, fertilizers, pesticides, automotive and other cleaning products properly.



Sweep off driveways and sidewalks with a broom instead of using a hose and water. Plus, NO power-washing unless you can collect or recover the polluted washed water.

Wash your car to a local car wash facility. This helps keep detergents and other cleaning agents from entering storm drains. Even labeled "earth-friendly" or "biodegradable" products can be harmful to our local waterways.



Always pick up pet waste and trash and dispose of responsibly.

Hire contractors that understand and will comply with the rules and regulations of the local jurisdiction. If you have questions, please contact the City. We are always ready to help.



Do not pump water from pool, spa or ponds directly into an area drain. Pools and other water features have chemicals, which require proper treatment. Contact the City before emptying your pool, spa or pond.

Report any non-storm water discharge to the City immediately.

The City offers several ways you can report a storm water or pollution problem. We're Here to Help. Another easy way to report stormwater violations is by downloading the free MyCommunity App that enables users to report location-specific concerns including urban runoff issues or other pollution concerns. The app is available for free on the Apple Store (iPhones) or Google Play Store (Androids). Search for City of Solana Beach.

# PLASTIC FREE SOLANA BEACH

Global Problem. Local Solutions.

Last year, plastic accounted for 53 percent of the beach litter on San Diego County beaches. Plastic pollution is a global problem and on September 25th City Council passed a new ordinance to combat the issue. The ordinance implements a variety of new policies most of which will go into effect next year, but some sooner.

**No more trash from take out.** Beginning this November, residents may bring their own reusable cups to fill up on to-go drink orders at any food establishment in the City thanks to the newly adopted ordinance. Restaurants also have the option to place to-go orders into a customer's own reusable food containers due to updates made this year to the California Food Health and Safety Code. The SB ordinance makes it a requirement for restaurants to accept reusable cups, but at this time, it is not mandatory for them to accept a customer's take-out containers. But, if you are interested in reducing plastic waste you might encourage them to do so.

If you do not have your own take-out containers, then beginning November 1, 2020 restaurants will only provide ones that are recyclable or compostable, so be sure to dispose of them in the correct bins. The following provisions will also **take effect on November 1, 2020:**

- Food establishments will no longer automatically give out utensils, condiments, napkins, straws or other similar items unless a customer specifically asks for those items. If you are bringing take-out home, you likely have most of the items you need at home. If not, or if you are going on a picnic, do not forget to ask for the items you need!
- Stores will not sell and restaurants will not provide the following plastic items: plastic straws, utensils, stirrers, splash sticks, cocktail sticks or toothpicks. Wooden, paper or other compostable alternatives will be available if requested by the customer.
